# License to Sell

**BE IT KNOWN THAT** this License to Sell is hereby issued for the sale of lots of **KC HOMES SUBDIVISION** located in **Brgy. Tamontaka, Datu Odin Sinsuat, Maguindanao del Norte** pursuant to **BP 220- Economic Housing** as well as the rules and regulations issued pursuant thereto.

AND THAT its owner/developer Kaise T. Usman / Landlan Realty and Development Corp. shall be obliged to do and perform the following:

- Complete the project in accordance with the approved development plan therefore not later than <u>Dec 2028</u> and advice buyers in writing of such time frame for development;
- 2. Maintain the common facilities until their turnover is authorized pursuant to PD 1216;
- 3. Register the instrument relative to any sale with Registry of Deeds, whether or not the price is fully paid within 180 days from execution.
- 4. Deliver the title free from the liens and encumbrance to fully paid buyers or, if mortgaged, redeem and deliver the same within six months from full payment;
- 5. Secure clearance prior to any mortgage, alteration of plans, advertisement or change of name of ownership:
- 6. Pay the real estate tax/assessment on the lot/unit until the year the title is transferred to or actual possession /occupation is taken by the buyer;
- 7. Refrain from forfeiting payments made by the buyers who suspend amortization after due notice to owner or developer on ground of incomplete development or non-development;
- 8. Within sixty (60) days after the end of each semester, submit the semi-annual reports on any changes in corporate officers and their addresses and on operations showing the sales status (indicating therein lot/block number, TCT Number, date of purchase, name of mortgagee, and mode of acquisition), and extent/development status;
- 9. Sell only at the maximum selling price of **P2,500,000.00**
- 10. Provide the buyer of house and lot, lot only, or condominium units the option to avail of home financing scheme of his/her choice;
- 11. Display the registration certificate and this license in a conspicuous place in all offices of the owner and developer;
- 12. Initiate the organization of organization of home unit's owners;
- 13. Refrain from levying fee for an alleged community benefit upon the buyers; and
- 14. Comply with other provisions of the pertinent laws, rules and regulations.

Any misrepresentation or material falsehood made in connection with the issuance of the Certificate of Registration of the project, the License to Sell and the submission of documents in support thereof, and failure to comply with any of the conditions set forth herein shall be a valid cause for the suspension and/or revocation of this License.
